

#### MERRITT LANGDON

Born in North Carolina about 1833, Merritt Langdon was the son of Britton Langdon, Sr. and Margaret "Peggy" Carroll. On December 30<sup>th</sup>, 1856, he married Margaret I. Stephenson, born about 1838, daughter of Benjamin and Margaret "Peggy" Cross Stephenson. Together they had two children, Effie Langdon, born about 1857, and Bernice H. Langdon, born April 14<sup>th</sup>, 1858.

Merritt enlisted in Company C, 5th Infantry Regiment North Carolina on July 15<sup>th</sup>, 1862. He died of pneumonia on January 2<sup>nd</sup>, 1863 in Richmond,
