

ZACHARIAH LANGDON

Born in Johnston County, North Carolina on January 13th, 1826, Zachariah Langdon was the son of Britton Langdon, Sr. and Margaret "Peggy" Carroll. On February 4th, 1849, he married Elizabeth "Betty" Johnson, born, March 30th, 1828, daughter of Amos and Sarah Tomlinson Johnson.

Together they had seven children, Marticia Ann Langdon, born January 16th, 1849, Rufus C. Langdon, born April 24th, 1850, Sarah Langdon, born March 24th, 1852, James Monroe Langdon, born June 29th, 1854, Richard F. Langdon, born October 12th, 1856, Eleanor "Ella" Langdon, born April 28th, 1859, and Talitha Delia Langdon, born August 1862.

Zachariah enlisted in Company K, 49th Infantry Regiment North Carolina on June 1st, 1863. He deserted on August 11th, 1864.
